

## COLONEL QADDAFI SAYS: "ISLAMIC RELIGION DOES NOT JUSTIFY THE SHAH OF IRAN TOINVADE OMAN"

Colonel Muammar addafi, President of the Revolutionary
Command Council of Libya, reaffirmed the stand of the Libyan
Arab Republic by the size of the struggle of the Omani people
against the Iranian invasion forces and British colonialism,
the Jordanianinterference and the puppet regime in Muscat, and
asked the Arab rulers to take a unified stand for expelling the
Iranian invaders and the Jordanians and "nglo-"merican colonialism
and the foreign presence in Oman. Colonel Muammar Laddafi
described the silence of the Arab rulers over the Iranian
invasion of Oman as submission and full of fear and said that some
Arab governments keep silent over the Iranian interference due to
the financial enticements extended by Iran to them.

Colonel Qaddafi affirmed the cohesion and alliance of the Libyan revolution with the struggle of the Omani people and the People's Democratic Republic of Yemen in facing the Iranian invasion. He asked: under what right the Shah is allowed to send his armies for invading Oman and killing the Omani people and occupying the Arab islands. There is no justification for that.

Colonel Qaddafi was delivering a speech at the Arab Youth Festival now in session in Tripoli in the Arab Republic of Libya.

### WOMEN DELEGATION FROM OMANI WOMEN'S ORGANISATION ON THE PROPERTY OF THE PROPER

An Omani women's delegation from the Organisation of Omani Women is participating in the symposium organised by the Soviet Women's Committee at 'al-Matta' in the Soviet Union under the title: "The role of the Joman in the Economic Development and Bring-up of the new Generation" which is being held during the period 10-19 July. ## Memorandum of Arab Jurists | Federation to Arab League | DEMANDS EXPUISION OF SULVANATE'S MEMBERSHIP AND LIQUIDATION OF FOREIGN TRISENCE FROM OMAN

The Fermanent Bureau of the Arab Jurists Federation sent a memorandum to the Secretary General of the Arab League and other Arab League members resenting the acceptance of the traitorous regime in Muscat as member in the Arab League. This regime does not possess the simplest qualifications for membership.

The memorandum of the Arab jurists explained the conditions prevailing in Oman comprehensively and demonstrated by fact and evidences the redity of foreign colonialism of Oman and the British and Iranian treaties, bases and airfields existing in Oman which tries had some of them concluded during the era of puppet Qaboos. The memorandum said:-

"The question of the independence of the Sultanate of Oman and its acceptance in the membership of the Arab League stirs a lot of queries. How then the Arab League permits a regime such as the Muscat regime to be a member in it." The memorandum added:
"We are confident that the Arab League knows the type of independence enjoyed by the Sultanate of Oman".

The permanent Bureau of the Arab Jurists Federation also explained the size of Iranian invasion and occupation of a number of islands and Omani territories and its military interference in a bid to repress the Omani revolution. It also showed the size of Jordanian militaryinterference and the reality of the so-ecalled Sultanate which is administered by British officers, and political advisers and finally the granting to American imperialism of Masirah base for transforming it into another aggressive base.

At the end of the memorandum the Arab jurists asked the Arab League to expel the puppet Jaboos regime from the membership of the Arab League and demanded the interference of the Arab League in the adoption of essential methods and means for expelling all foreign forces and bases from Oman and to leave the Omani people determine their own future by themselves. The Arab Jurists Federation also asked the Arab League to interfere for the release of all political prisoners from the prisons of Muscat and to halt the campaigns of torture and arrests against theOmani citizens.

The following is the text of the mesage addressed by the Arab Jurists Federation to the Embassy of the Muscat puppers in Beirut:-

"We wish to inform you that the Permanent Bureau of the Arab Jurists Federation which was held in Baghdad during the period 4th to 6th May, after reviewing the general conditions In the Arab area and inasmuchas the matter is connected with the bad condition of the political detainees in the Sultanate of Oman it was decided to send a three-member commission from the Permanent Bureau to visit the prisobs of the Sultanate in order to get acquainted with the conditions of the political prisoners and to find out facts. Please notify your government with that to facilitate the assignment of the commission."

### ARAB STUDENTS CELEBRATE TENTH ANIVERSARY OF 9th JUNE REVOLUTION IN YUGOSLAVIA

The branch of the General National Union of Yemeni S, udents in Yugoslavia issued a statementon the occasion of the tenth anniversary of the armed revolution in Oman in which they explained the nature of the conspiracion and the campaigns of imperialism and reaction which are being faced by the Omani revolution whose victories started to pose danger to theinterests of imperialism and reaction in the area of Oman and the Arabian Gulf. statement resented the Iranian invasion of Oman and said that Iran is the staircase of American imperialism which aims at realising several targets including the extinguishment of the Omani revolution and the toppling down of the progressive regime in the People's Democratic Republic of Yemen. Therefore. the imperialist invasion and the Iranian invaders are now mbbilising their forces and building military bases and airfields in different parts of Oman and across the eastern borders of the People's Democratic Republic of Yemen with the aim of implementing their aggressive plan. The statement also condemned the puppet Jordanian reactionary interference in Oman and despatch of the Jordanian army and aircraft to fight the Omani peoplebeside the invaders and colonialists. The statement said that the Jordanian regime is well known for its hiredom to world imperialism and is the sworn enemy of the Arab liberation movement which is working to crush it. The statement asked the Arab countries to stop aid for the puppet jordanian regime and to extend every backing to the Omani revolution. It also demanded the release of the political detainees and prisoners in Muscat.

#### ARAB STUDENTS - Cont'd.

It is worth recalling that the branch of the Yemeni Students Union and the office of the Palestine Liberation Organisation in Yugoslavia have held a symposium on the revolution which was attended by the Arab students and continued for nearly three hours. The Yemeni students have also distributed statements and circulars and newspapers of the revolution to all Yugoslav towns in which foreign Arab students are present. Moreoever, in May a week was held in solidarity with the struggle of the Omani people in the town of "Nich" in collaboration with the Yemeni students and the Club for Friendship with beoples in Yugoslavia.

Meanwhile, A solidarity meeting was had in France with the revolution of 9th June. This was attended by the branches of the Arab unions and Committees in support of the revolution.

During this meeting they condemned the Iranian invasion of Oman and also resented and deplored the stands of the Arab governments and their silence over the invasion which threatens the Arabism of the area of Oman and the Arabian Gulf.

In their resolutions they stressed the importance of the Arabian Gulf area, strategically and economically to imperialism which is moving its watchdogs, the Iranian and Arab reactions, to extinguish the liberation spirit which is ablaze in the area and to ensure the influence and hegemony completely of imperialism over this area.

They said that the presence of the Omani revolution gives a lively example of the struggle of all peoples including the Iranian peoples.

The resolutions of the meeting also said: The Shah of Iran is using cheuvenist racism and nationality as a tool to hide behind it the reality of thei nvasion. The conferers praised the braveness of the People's Liberation army and the People's Militia in checking off the recent Iranian attack on the Western Region of Dhofar and called for further solidarity and effectiveness of this solidarity in a practical and remarkable manner backing the struggle of the Arab people of Oman. After the solidarity meeting the front's film "The Liberation Hour Struck" was screened followed by a debate on the situation in Oman.
