ALL THESE DELEGATIONS - WHAT DO THEY REPRESENT ?

- ** What are the Common and Individual Objectives of Imperialism and the Retrogrades ?
- ** The Revolutionary Masses Would Raid All Imperialist Plans.

A new political movement is going on in the Gulf Area aimed to accelerate imperialist plan S. During the last two weeks three delegations visited the Arabian Gulf viz:-

- * The joint Kuwait/Saudi Delegation
- * Sir William Luce
- * Frank Shakespeare, the American Director of Information.

All these delegations have a common denominator and that is to pool their efforts ~~together~~ to bring the ignorant Sheikhs to realise and sense their duties towards International Imperialism and the plans of Neo-colonialism. They, and more especially the Kuwait/Saudi Delegation, are working to make these Sheikhs understand "the importance of a Federal existence ... before it is too late ... and before we are

surprised by a de facto situation which wrecks all hope for the desired Federation ... " to quote the hireling Abdulla Hussein Neema of ALARCOBA newspaper in his comment on the situation in the Gulf. The joint Delegation carried proposals to postpone secondary issues such as the Capital and the representation according to population, for a period of four years. It nevertheless proposed the necessity for external Defence. Should it not be possible, due to the many conflicts which rock the Federation boat, to give birth to a healthy Federation able to serve the imperialist ends more effectively, then a Federation may be born which may retain its internal conflicts on one proviso and that is the necessity to unite the Imperialist and Retrogressive forces in order to face the forces of revolution representing the interests of the masses. The Gulf newspaper issued in Sharga expresses this by saying that Saudi Arabia and Kuwait whisthat "... the Federation should come about in order to serve as a bastion in the face of the infiltration of leftist political forces in that area upon which the West depends in regard to the major part of its oil supplies".

Recent revolutionary events in Ras al Khaima have had their effect on these hirelings. The British Commandos and the forces ~~xx xxxxxxxxxx~~ of the hireling Qabus failed to strike at or lay hand on any of the revolutionaries. The Sheikh Bakha of the revolution area was forced to relinquish the area, under pressure, in favour of the Sultanate in spite of the fact that the area was a part of Ras al Khaima officially. Day to day developments in the area compel these hirelings to come closer and untie to face them.

So much for the common objective. But each party has its own aims. Kuwait and Saudi Arabia are "two Arab Conservative States whose security would be endangered by any political upheavals in the Gulf" to quote the Gulf newspaper. Saudi Arabia, representing the Americans in particular, desires the creation of a Federated State enjoying relative independence vis a vis conflicting western interests in place of a continuation of giving preferential treatment to British interests. The Kuwait Government too

has its own interests in the formation of the Federation and in the opportunities for investing surplus Kuwait capital.

William Luce, the British Foreign Minister, came to assess the situation and find out how suitable are the circumstances for the withdrawal and operation from the northern parts of the Gulf, which seem to have been put off longer. Lord Balfour declared recently that Britain would not withdraw its forces from the Gulf because there was still need for them there.

in the area In conclusion there is the visit of Frank Shakespeare, the Director of Information of America which enjoys a great economic and clear political influence in Saudi Arabia and Iran which it does not yet have in the Gulf. It therefore aspires to have such influence and to take into consideration the necessity to give the British Imperialists the opportunity to tidy things up by virtue of their experience. Shakespeare's visit in particular is not a coincidence but reflects the methods of America with its provocative and awful presence. That has been preceded by visits which units of the Seventh Fleet made to Dubai. Previously American Forces took part in joint manoeuvres with Iran and Britain.

All these Delegations come and go in order to plan and act in detriment of the interests of our people and the interests of the masses who were trod on for long by the alliance between the Imperialists and retrogrades sucking their wealth. But in spite of all conspiracies and plannings, these masses under the leadership of their Revolutionary Forces would defeat the conspirators and win victory.

- * Anti-Revolutionary Forces and the 12th September Movement
- ** Influx of American Capital - A Primary Step to Extend Military Bases
- *** Theoretical, Military and Political Escalation of the National Democratic Revolutionary Movement

(Released by the Popular Front for the Liberation of Occupied Arabian Gulf, in connection with the retrogressive and divisive move of the 12th September started by the anti-revolutionary forces in the Eastern Area.)

(The Natural lead to an understanding of events in the Eastern Area is to be found in the knowledge of the nature of the phase through which the struggle of the labouring masses in the Gulf and the Peninsula is passing. It is likewise to be found in understanding the nature of the combatant and opposing forces to gain ground. Our review of the general situation and of the existing struggle in the Gulf Area and the Arabian Peninsula in particular and the Arab and the International world in general, endeavours to define the forces of both the Revolution and Anti-Revolution. It is hoped the reader would be able to assimilate into the events and developments in the Eastern Area as a phenomena of the natural and identical objective circumstances of the struggle between true forces of Revolution and the forces of International Imperialism together with their class allies. To take events in the Eastern Area in seclusion of the overall colonial pattern for the whole area and as distinct from the general strategy of International Imperialism and the latter's plannings and conspiracies against all colonised and oppressed peoples to stem their severe and earnest struggle, would only alienate us (and the reader) from a true understanding of the situation and the struggle prevailing in the Gulf Area in particular and the Arab and International world in general. We would otherwise fail to grasp International Imperialist and Reactionary plans and preparations to combat the struggle of the poor masses all along the Arabian and universal field.)

What is this Phase then and what is the nature of the Forces facing each other within ?

For a century and a quarter British Colonialism and American Imperialism have been manipulating the wealth and resources of the Arabian zone. The Gulf Area has been planted with their military bases to face all possibilities of revolutionary development in the whole Arabian and Universal area. Britain, together with its colonialist and reactionary allies, has endeavoured by concerted effort and presence as well as its deep methods in the area, to prevent the spread of the spread of the spark of National Revolution and by its far-reaching means and class-conscious forces managed to nip the first national uprisings in Oman, Bahrain and Qatar in the bud. Its aim being to impose its rule and protect its influence and interests and the interests of its allies. With the advent of the second half of the Twentieth Century the

Arabian zone began to feel a national boredom which spread to a number of its component parts. The victory of the Revolution in the South and the expelling and sweeping away of British colonialism from there had its great effect in securing the base of Revolution in the Arabian Gulf. This brought about an exchange of places between British and American imperialism. American capital began to invade the area in preparation for an expansion of its military bases which in turn would facilitate its final overlordship of the whole situation in the area and inherit the interests of the ageing Empire through the control of international capital. It (America) would also exercise direct monopoly of the universal market having occupied the place of Old colonialism after replacing its out-dated forms by a neo-colonialism to fit the age. This is reflected in principle through foreign capital on the one hand and a full control of national resources on the other. The discovery of oil in the Gulf Area brought about a radical change in the social structure of society in the Gulf, as well as a change to the economic, political and class framework within the area. On the light of these changes relations of class and politics took a different shape. So did the nature of struggle which envelops the Gulf society. Thus British Imperialism, with all its class-conscious Allies, set their plans and policies to ensure the safeguarding of their economic, strategic and political interests in the area. They established a number of weakling entities as satellites in order to be under protection and obediently carry out their reactionary and conspiring plans and schemes. Such a social entity is reflected in the Emirs and Shieks and the forces of tribal feudalism who are strongly bound to Colonialism and international imperialism by bonds of interest and class, and who act as guardians for their interests. Through such a camouflage and paper-regimes of hirelings in the area, the operation to bleed and disown our labouring people of their wealth and resources was performed. Such (reactionary) forces have always served as a bridge for all economic and strategic interests of International Imperialism who, through such forces of reaction exercise a control over the oppressed and poor masses who aspire to be saved and set free from the hold of Imperialist and Reactionary Forces. Such poor masses wish to build for themselves a society which would mark the end of one human being exploiting a brother human being.

This broad front of hostiles consisting of British and American Imperialism, Emirs, Sheikhs, the bourgeoisie, landlords and feudalists on one side is faced by another broad national front which includes all class-conscious forces which have a stake in the Revolution as well as other sectors of the people who have an interest in terminating such a colonial and reactionary state of affairs. Vanguards of these forces who are hostile to Colonialism and international imperialism, are the poor labourers and farmers as well as the educated revolutionaries who comprise the main and basic force in the struggle with International Imperialism and all their class-conscious allies. These forces shoulder the responsibility for the national phase, its leadership and achievement. They cannot in their capacity as class-ridden, poor and oppressed force, achieve and be responsible for the democratic national phase without a complete and total liquidation of all forms of colonialist presence both old and new and without the uprooting of tribal feudalism. They can only attain their goal "through revolutionary practices, hard

struggle and a qualitative and quantitative development of their methods of confrontation and challenge of all forces of International Imperialism. First and foremost of such methods and means or forms is the escalation in the theoretical, political and military fronts of the Armed National Democratic Revolutionary Movement. The only sound and true way to get rid of and be saved from universal colonialisation of colonised, semi-colonised and oppressed peoples all over the world, is to place the Gulf Area on the threshold of a long-term popular war of liberation and to boost it ahead with a national programme enlisting all the country's potentials in the material, man-power and moral aspects of the great and poverty-stricken masses in their earnest struggle against the forces of International Imperialism."

* National Liberation Movements Constitute a Major Danger to Imperialism :

** The Part played by the 9th of June Revolution .

The expansion and progress of National Liberation Movements and Armed Struggle against international imperialism and its class-conscious Allies launched the class-struggle in the world into a new, decisive phase. This increasing and growing revolutionary pressure in the continents of Asia, Africa and Latin America is universal. The Movement of National Democratic Liberation and its armed revolutionary activities have become a major source of danger to International Imperialism and all their class-conscious Allies. This a revolutionary saying and unworthy of doubting its authenticity. The experiences of oppressed revolutionary peoples in the world is the best solid proof of that. A quick glance on all the resolutions and matters covered by the Second Conference of the Popular Front sufficiently clarifies the extent of such resolutions and how sound they were, since they constituted the real and scientific answer to all the plans and policies being worked out by Britain, America and Arab reactionaries against our toiling people and their National Democratic Movement. It was these resolutions which stemmed from the heart of the practical experience of the Armed Revolution, which placed the Gulf Area for the first time on the threshold of a new and decisive phase in its struggle against the forces of Colonialism and International Imperialism with all their class-conscious Allies, and which won for the 9th June revolution an overall strategic depth and a clear progressive front. Thanks to such serious and effective channeling of the 9th June Revolution and to the achievements and gains which it realised for the poor masses in the Gulf, it now constitutes a major and overwhelming danger to the interests of International Colonialism and Imperialism and Arab reactionaries in the area. Moreover all developments and changes in quantity and quality which the 9th June Revolution introduced, have coincided with the overall developments and changes in quantity and quality which began to clearly shape up in the pan-Arab Progressive National Movement following the defeat of the 5th June.

Since then the Arab region in particular has been subjected to a reactionary Imperialist attack aiming at bringing to an end the hot revolutionary flare-up which erupted therein at several places, and aiming also to liquidate the revolutionary spots of ignition. International imperialism and its class-conscious allies fully evaluate this revolutionary situation and realise the danger which its development and extension would bring about to threaten to bring an end to their interests.

THE ATTACK OF IMPERIALISM AGAINST THE GULF AREA

The attack of reactionary imperialism on our region, and in particular that of the Gulf, has become clearer than at any time before. The horizons for this imperialist reactionary offensive began to crystallise in an area such as the Gulf where are gathered together the interests of international imperialism and where continues the process of exploiting our vast petroleum wealth which international monopolies eye with greed. It is here that the revolution is spreading and developing and constituting a real danger on colonial presence and the interests of its monopolising companies, wherefor plans and conspiracies began to be implemented in as much as colonialism and its hiring tools "imagine" an ability to crush the revolution and liquidate it once and for all. As a result of these plans, therefore Act I of the shaky Play was introduced to the stage where the hiring Qabus succeeds his hiring father Saeed Bin Taimur:-

I. Deposition of Saeed Bin Taimur

This event is neither new nor coincidental. It is the result of a long-standing colonialist reactionary plan ever reflected in its far reaching aim in all imperialist moves against every colonised and semi-colonised nation and every nation suffering under the yoke of exploitation. It is ~~xxxx~~ a preparation in principle against national liberation ~~xxxx~~ ~~xxx~~ movement in the Gulf in particular and in the Arab and universal world in general. Such a hiring regime is the legitimate offspring (son) of the Anglo-American Imperialism and Arab reactionaries. The fake promises of reforms and democracy promised by the hiring regime, on the minor side such as setting some of the victims of the deposed Sultan free etc., are but a part of a reactionary colonialist plan aiming to liquidate the revolution and the cause of the poor masses and distract them from their burning bitterness through such minor and false promises.

2. The Divisive Move in the Eastern Area

This is where we would like to define what part the divisive move, which took place in the Eastern Area, plays in the overall imperialist and reactionary plan. The divisive move represents a shaky part in the hostile imperialist reactionary moves and is but a second step and a new knot in a chain to try and liquidate the Armed Popular Revolution all along the Gulf. The move by the anti-revolutionary forces in the interior and their disturbances on the 12th September which are divisive in the Eastern Area are a basic part of the imperialist reactionary conspiracies against our people and against all their aspirations and progressive socialist efforts.

- * What is this move? What atmosphere brought it about?
What are its basic ingredients?

Before the anti-revolutionary forces embarked on their divisive reactionary move on the 12th September 1970 in the Eastern Area, they prepared an atmosphere of unrest

detonated by artificially strained situation. The field of the masses was strewn with gossip and diverse unfounded rumours against the revolution and the revolutionary cadres. Some of these rumours, for example, took the following shape:-

"The National Front is Communist. All its political guides are atheists who are out to destroy religion and Islamic traditions. Most of the General Command members are atheists and delinquents. All Women in the camp are prostitutes."

Through this propaganda and false fabrications they were able to strain the National atmosphere and create an unnatural atmosphere between the National Front, the revolutionary Cadres and the General Command, on the one hand, and the masses of the people in the Eastern Area, on the other. They were assisted therein by a number of personal and objective circumstances prevailing in the Area. Under these unnatural circumstances and in such an unhealthy atmosphere created by the anti-revolutionary forces in cooperation with the hiring authority in Oman, the anti-revolutionary forces embarked on their divisive move of the 12th September 1970 in the Eastern Area. They arrested 40 cadres of the Popular Liberation Army, militia and members of the General Command who were available in the Eastern Area. Their basic objective was to hand over all those detained to the Authority but they could not do so under the pressure, influence and intervention of the Popular Liberation Army forces who were present in the Eastern Area following the divisive move. The anti-revolutionary forces' objective behind their divisive move was the realisation of a number of aims of which we enumerate the following :-

i) Principally to liquidate the revolutionary cadres and elements in the Eastern Area (within the Popular Liberation Army and the Popular Militia)

ii) As a result of the principal step (i) to separate the Eastern Area from the remaining part of the Liberated Area of Dhofar and thus to facilitate a close upon and a siege of the remaining areas;

iii) And as a result of the principal steps (i) and (ii) to liquidate the 9th June Revolution by phased stages and to deny it all its ideologic, political and strategic achievements. In this way the anti-revolutionary forces would have achieved one of the radical aims of the reactionary imperialist conspiracy against our people in the Gulf and Arabian Peninsula. This was their aspiration had their divisive move succeeded. From the first birthday of this mean divisive move which was born on the 12th September and died on the 30th of the same month, the Popular Revolutionary Forces including the Popular Liberation Army and People's militia, revolutionary cadres and General Command as well as the vast majority of masses, have all stood together to face this counter and reactionary move with all due understanding and responsibility and with due consideration to its real aims and far-reaching objectives. In the face of this dangerous situation the Popular Revolutionary Forces applied all the prompt sound and effective solutions to strike at all the aims which the elements of the divisive move with their overlords, had in mind. These radical solutions and revolutionary appliances managed to save the people and the revolution from the aims of the elements of division which were to create a terrible national warfare and to bring the revolution in a fight against the masses and the masses against the revolution. Thus was lost the opportunity to the

anti-revolutionary elements and the hireling authority whose only aim is to bring about destruction to our people. And so the Revolutionary Forces were able to remain in full control of the whole situation in the Eastern Area, and to direct severe blows to the divisive and reactionary elements and their masters the international colonial and reactionary forces. They exposed all the mean methods and hireling alliances for these forces which are hostile to the poverty-stricken masses and who want to bring back the clock of history backwards. The fact that some elements who managed to get away temporarily from punishment at the hands of the People, have surrendered to the authority in hireling Oman, is the best proof of their linking to the authority and is the best proof also of the unreality of all masks they put on to mislead the vast masses. Unshakeable evidence has also appeared about the how ph physically intertwined was this divisive move, on the one part, and the plans of international colonialism and imperialism in the whole Gulf area and the Arabian Peninsula, on the other.

3, Complementing the Imperialist Plan to Attempt a Blow to the Revolution in the People's Democratic Republic of Yemen

The near timing of events and developments in the Fourth and Fifth Governorates of the People's Democratic Republic of Yemen and the attack launched by the anti-revolutionary forces against these areas with a view to separate them from the Republic proper as a step in the direction of liquidating the Revolution in Arabia, has an intertwined, harmonic and common objective with the reactionary divisive movement experienced in the Eastern Area of the Dhofar region in the Occupied Arabian Gulf. We can therefore realise that the 12th September divisive move is not an alien phenomena but a natural by-product imposed by the nature of existing struggle between the Popular Revolutionary Forces on the one hand and the forces of International imperialism and its class-conscious Allies on the other. As the 12th September move breathed its last breath on the 30th September, against the rock of the stand of our struggling people and its brave revolutionary cadets, so will all colonial and imperialist conspiracies fall to pieces against the same rock.
