CIRCULAR TO COMMITTEES OF SUPPORT AND SUPPORTERS

No doubt you are following the statements made by the Secretary General of the Arab League Mahmood Riad in connection with the League's Committee for finding cut facts in Oman which is emanating from the Arab Foreign Ministers meeting in Tunis in March, 1974.

Mahmood Riad and some members in the committee such as Tunis, have twisted and deviated the assignment of the committee from a committee for finding out facts about the colonialist presence in than and the Iranian invasion of Oman as well as the open military presence of Britain, Iranian and Jordan into a committee for supporting the traitorous regime in Muscat and for justifying the Iranian invasion and the foreign presence. These practical steps came as part of the following plan:-

- 1) The committee headed by MahmoodRiad went and met the Sheikhs of Kuwait and Abu Dhabi and traitor Qaboos. Mahmood Riad valued his interviews with them and praised them and in accordance with what was published by the Sultanate's newspapers including "al-Aqida" which is closely linked with the authority, Mahmood Riad is convinced with the viewpoint of the Sultanate.
- 2) Mahmood Riad abstained and pressed upon not implementing the resolution for forming the committee. This is done when the committee refrained from visiting the liberated zone and sitting with the other party in the dispute (the People's Front) and to see with its own eyes the consequences of the Iranian invasion, the British presence and the aggressive war.
- 3) Mahmood Riad crowned such behaviour with a statement in which he said: "The committee heard all parties in the dispute now going on in Oman" and that he called it to meet for submitting its report". In fact he only heard the party hostile to the masses of the Omani people.

This calls upon the support committees and the supporters of the revolution everywhere to foil this new conspiracy with which it is wanted to create the justification for liquidating the revolution by Arab spears after the Iranian spears have failed to achieve that.

In the event that the committee came out with its report, which is expected to be partial, it is necessary to adopt a decisive stand towards the league and its representatives everywhere to make them know that the masses of the Arab people and the national forces do not accept to let the league be used as a justification for slaying our revolution as had the resistance in Jordan been slaughtered under the curtain of the league's committee.
